How to speak at a MODD Growl:

Report your Degree & Tag Number	PDD, or DD, or PUP
Report your name	John Smith
Report your Pound Number	Pound # 210
Report your Pack Location	North Carolina Pack

Then, when acknowledged by the Chair, you may speak your piece

If you are fined, you have the right to request council  
(someone to plead your case, hoping for a dismissal of the fine)

Remember, NEVER say meeting – it's a GROWL  
NEVER say minutes – they are scratchings

\$1.00 – is a BIG BONE fine  
\$0.25 – is a small BONE fine
